Summary of Proposed Amendments to the College Constitution

An overview of the key changes proposed to the Constitution of the College is detailed in the table below. The table below does not purport to summarise all changes and is intended to be a summary only. | Honorary Fellow | 5.5 | 12 - Other changes | Simplification of clause 5.5 and clarification that an Honorary Fellow need not be a Medical Practitioner |

| Training program | 5.10.1 | 10 - Other minor membership changes | Assessments are one aspect of the whole training program. There is no need to single this out. |

| Rights of Fellows | 5.17.1 | 12 - Other changes | Since we are proposing the decouple of the right to vote in general meetings from the right to vote in the election of the President-Elect, we need to clarify in this clause that Fellows are entitled to vote on the election of the President-Elect, and eligible to be elected as President-Elect. |
| Rights of members of proposed new classes of membership | 5.17.2 | 1 to 5 - New membership classes | We note that they already have that right, it's just a clarification. The proposal is to establish the new membership classes as mechanism for engagement with the College, rather than involvement in its governance. Their rights will therefore be limited and similar to those of Affiliates. |
| Rights of Honorary Fellows | 5.17.3 | 10 - Other minor Membership changes | Proposal to provide Honorary Fellows the right to be appointed as a Director with special expertise. |
| Rights of Associate Fellows | 5.17.4 | 7 and 9 - Voting rights Associate Fellows | Proposal to give Associate Fellows the right to vote at general meetings, and vote in the election of the President-Elect The Constitution already provides for two Associate Fellows to be nominated and elected by those Associate Fellows entitled to vote on their election (clause 11.1.4). We want to clarify Clause 5.17.3 to reflect these provisions. |
| Rights of Candidates | 5.17.5 | 6 and 8 - Voting rights Candidates | Proposal to give Candidates the right to vote at general meetings, and vote in the election of the President-Elect The Constitution already provides for one Candidate to be nominated and elected by those Candidates entitled to vote on their election (clause 11.1.5). We want to clarify Clause 5.17.3 to reflect these provisions. |

| Admission to Fellowship | 5.30 | 12 - Other changes | To be members of the Candidate class, medical practitioners must be participating in the Fellowship Training Program. Once a Candidate completes the FTP, which is a requirement to apply to be admitted as a Fellow, they cease to be a Candidate. Therefore the Board cannot admit to Fellowship someone who is a current Candidate of the College, and clause 5.30.1 should be deleted |
| Notification of changes | 5.34 | 12 - Other changes | The College must be aware of changes to members' circumstances, including changes to their registration as medical practitioners. |

| Advice to the Board on CPD | 7.1 | 12 - Other changes | The CPD Program Committee now reports directly to the Board, not through the Education and Training Committee. It therefore provides direct advice to the Board in relation to continuing professional development |

| Decision-making process | 8.1.2 | 12 - Other changes | The Board has authority to approve and revoke policies from time to time. There is no reason why a policy governing continuing professional development, whose requirements are prescribed by the Australian Medical Council / Medical Council of New Zealand should require the vote of Members at a general meeting. |

| | | | The clause has been reworded to remove all these members from the need to maintain registration as a Medical practitioner. |
| Revocation of medical registration | 9.13 | 12 - Other changes | Clarify that only those Members who are required to be a Medical Practitioner will cease to be a Member if they fail to maintain their registration |
| Suspension of medical registration | 9.14 | 10 - Other minor Membership changes | The title of the section provided for suspension of medical registration but there was no content. Suspension is different to revocation and should be considered separately. |
| | | | This new clause enables the Board to suspend the membership of a member of their medical registration is suspended. |
| Awards, prizes and other recognition | 9.19.5 | 10 - Other minor Membership changes | The Board may decide to remove or revoke any awards, prizes or other recognition given to a member by the College where clause 9 is triggered. |

| Resolution in writing | 10.47 | 12 - Other changes | Members who are not entitled to vote should not have the power to contribute to a determination of the Members |

| Section name | Before clause 10.58 | 12 - Other changes | The constitution already provides for elections and polls to be postal, electronic, or both so we propose an amendment to rename the section from "postal ballots" to "ballots". |
| Ballots distribution | 10.60.3, 10.60.8 | 12 - Other changes | Fellows may not be the only members entitled to vote in the future. Ballots will be distributed to any Member entitled to vote. |

| Composition of the Board | 11.1.2, 11.1.3 | 12 - Other changes | The entitlement to vote at general meetings is different to the entitlement to vote on the election of the Board Directors. Clause 5.17 already outlines the rights of membership classes and who is entitled to vote on what. |
| Casual vacancy | 11.19.2 | 10 - Other minor Membership changes | Clarify that a casual vacancy arises if a Director ceases to be a member of the class under which they were elected or appointed. |

| Simplification of language | 12.2 | 12 - Other changes | Remove the double negative "not inconsistent" and replace with "consistent" |
| Quorum of the Board | 12.8 | 12 - Other changes | Proposal to achieve quorum of a meeting of the Board when at least five Directors are present, at least three of whom must be Fellows |

| Finance and Audit Committee | 14.1.2, 14.4.2 | 11 - Committees | Update of the name of the Finance and Audit committee to the Finance, Risk and Audit committee to reflect practice. |
| Board of Censors | 14.1.3, 14.4.4 | 11 - Committees | Removal of the Board of Censors as a standing committee of the Board given it reports to the Education and Training Committee. The committee will continue to exist and the Censor in Chief will continue to have to be a Fellow. |

| Chair of the Finance and Audit Committee | 14.10 | 11 - Committees | The chairperson of the Finance, Risk and Audit committee can be invited to speak at any committee, but should not be an <i>ex officio</i> member of all committees |
